#### **Real Estate Market Trends**

The Northern Virginia Association of Realtors® reports on <u>August 2009 home</u> <u>sales</u> activity for Fairfax and Arlington counties, Alexandria, Fairfax & Falls Church Cities, & towns of Vienna, Herndon and Clifton.

A total of 1,813 homes sold in August 2009, a .06% increase above August 2008 home sales of 1,812.

Active listings decreased by 23.66% from last year, with 7,016 active listings in 8/09, compared with 9,190 active homes available in August 2008.

The average days on market (DOM) for homes in August 2009 decreased by 27.59% to 63 days, compared with 87 days in August 2008.

Sales prices remain lower than those realized last year. The average sales price in August 2009 fell by 3.17% from August 2008, to \$458,172, compared with last Augusts' average of \$473,183 in 2008.

The number of pending home sales in Northern Virginia in August 2009 shows an increase of 9.7 % at 2,070 compared to 1,887 in August 2008. Consumer confidence has been strong for home purchases in our local market. Most of the activity involves first time buyers targeting <u>affordable and bargain-priced</u> <u>properties in the lower price ranges</u>.

Buyers: It's a great time to buy!

FHA loans up to\$729,750 with only 3.5% down are available to all qualified buyers, *not just first time buyers!* 

**Time is running out for the \$8000** Tax credit for first-time homebuyers buying as their primary residence, <u>expiring on 12/1/09</u>. For home buyers who need assistance with downpayment and closing costs, some state housing finance agencies offer a short-term loan based on the home buyer's qualification for the federal tax credit, so the \$8,000 credit can be monetized at settlement. #### NEIGHBORHOOD CONSERVATION UPDATE

The Neighborhood Conservation program is a program funded by Arlington County. It is currently the only way to get street infrastructure improvements in residential areas. Projects are selected by neighborhoods, and can be anything from park beautification, to playgrounds, to traffic calming.

### **Missing Links Projects**

Our last eligible missing link project in the neighborhood was completed recently on South Garfield Street just south of Second Street. Please join us in thanking Tony Halloin for all his efforts on missing links in the neighborhood!

## **Funded Arlington Heights Projects**

*Garfield Street* (0-100 block) – This streetscape project is virtually complete, with only streetlight and street trees to be installed. Congratulations to our Block Captains Philip Hipley and David Henry for their diligent representation!

*Fenwick Street* (0-100 block) – Just funded last winter, this project has been fully designed, and construction begun with a water line upgrade. Work on sidewalk, curb, gutter, street resurfacing and paving is expected to begin next Spring.

## Arlington Heights First Priority Proposed Project (not funded)

*Irving Street/Arlington Boulevard, Phase I* (0-100 blocks) – A new design of this project which preserves both street parking and the mature American elm trees passed petition this summer. This project will be considered for funding in December 2009, and is likely to be funded. The scope includes curb, gutter and streetlights, and improvement of the southwest side of the intersection with Arlington Boulevard (note that the southeast side – access road side -- will not be addressed until Phase II, noted below). Under current policy, the street must be widened, which necessitates removal of the sidewalk on the west (park) side of the street to make way for the utility poles.

## Other Projects in Queue (not funded)

*Irving Street/Arlington Boulevard, Phase II* – This project is to improve the access roads between Fillmore and Fenwick and between Hudson and Irving, as well as address the east side of the intersection at Irving and Arlington Blvd, and possibly other portions of Arlington Blvd bordering the highway. Please note that petitioning for this project has not yet been undertaken since the county has yet to determine what criteria an NC project along the highway should meet.

*Consolidated Streetlight Project (South Ivy from 7<sup>th</sup> to 9<sup>th</sup>, and South Highland from 7<sup>th</sup> to Columbia Pike, 9<sup>th</sup> Street Glebe to Walter Reed)* – Petitioning for this project is underway. Although the project had been petitioned previously, the petition is outdated, and it must be re-petitioned as a consolidated project. Consolidating the projects will allow the neighborhood to get more streetlights funded sooner.

*Fifth Street Streetlight Project* – Please contact Juliet Hiznay at <u>strangefruitblues@yahoo.com</u> or 703-685-2596 if you are the block captain for this project, were involved in the petitioning, or live on the street. The project is currently last in queue, and is a very small project (installation of just 2-3 streetlights). <u>At our Fall meeting, the community will begin a discussion on whether it would make sense to consider first a new project that would have a greater impact but is not likely to be otherwise funded in the current economic climate (e.g. possibly a project to replace the playground at the Thomas Jefferson Community Center).</u>

#### Wakefield High School Plans

Plans for the re-building of Wakefield High School continue to move forward. Last June the School Board approved the Schematic Design (what the building and grounds will look like). Since then, the architects, Bowie, Gridley Architects, along with the APS Design & Construction team have worked diligently on the building's Design Development phase - finalizing what the interior of the school will look like. It is expected that this design will be brought before the School Board for final approval next spring.

The new Wakefield not only will meet all school and educational specifications, but is also expected to meet the Gold LEED (Leader in Environmental & Energy Design) designation. Currently the School Board has requested the design team to determine the ability, the costs and the payback of installing a geothermal heating and cooling system.

Although many in the community would like to see it happen sooner, the expected construction start date is 2013-2014 and should take two to three years till completion.

\*Congregation Etz Hayim has begun construction to improve its facility.

\*New single-family homes are planned for the vacant lot on South Seventh at Glebe. This will be the first increase in housing stock to Arlington Heights since townhouse development was completed on Fifth Street South. Say goodbye to empty lot weeds!

\*Ethiopian Community Development Council received County Board approval to build Auximite Village, bringing new multi-family units to the Douglas Park neighborhood on South Highland Street, next to the Dunkin Donuts.

\*Sherwin Williams has opened a new store at the former Video Warehouse location on Glebe Road at Fifth Street South.

\*The schematic design for a new Wakefield High School is complete, with School Board tweaking, and pending review by the Building Level Planning Committee, the Planning Commission, and finally the County Board. Congratulations to our long time resident Cathy O'Malley for her work on this project!

\*The School Board has hired a consultant to study secondary school capacity issues, and might be looking at the Career Center as a possible site that could accommodate greater capacity. The Executive Committee will monitor this issue and report on any developments.
